LIFE MEMBERSHIP NOMINATION

Life membership of the Mount Gambier Motor Cycle Car Club Inc (MGMCC) is an honour bestowed to members who have rendered special or valuable services to the MGMCC well beyond that of a typical member.

Life membership will only be awarded to a person in respect of whom a resolution conferring life membership has been passed at a General Meeting of the MGMCC, on the recommendation of the Executive Committee. A life member so elected becomes entitled without payment of any subscriptions or other monies to all privileges of a financial member of the MGMCC. It is not necessary for life memberships to be awarded every year.

HOW TO MAKE A NOMINATION FOR LIFE MEMBERSHIP

Eligibility

The nominee must be a member of the MGMCC who has given exceptional and outstanding service to the MGMCC.

Nominations

Nominations are to be made on the form below, giving the details of the person nominated and brief reasons for the nomination. Nominations must be made and seconded by current MGMCC members.

Criteria

The following criteria should be addressed when nominating a candidate. It is helpful to include examples of how the nominee has gone above and beyond what could reasonably be expected of a member and why their contribution is worthy of recognition through life membership of the MGMCC.

The key elements that will be taken into account in awarding Life Membership are:

- have been ordinary members of the club for at least 10 years and have performed outstanding service to the club.
- contributions to the MGMCC which have enhanced its standing within its membership and the wider community
- commitment which does not seek personal reward, and
- a high level of recognition from the MGMCC's membership of the nominee's work for the MGMCC over a period of at least 10 years

Assessment

The current Executive Committee of the MGMCC shall meet to consider nominees for Life Membership in accordance with the above criteria. Any recommendations from the Executive Committee are to be made for consideration at the next practical General Meeting that year. The decision made at the General Meeting is final.

Notification

The secretary shall give to a person elected as life member written notice of his/her election and upon his/her intimating willingness to take up life membership he/she shall become a life member of the club.
